### Phillip Global Wealth Account (PGWA) / Foreign Investment

## i) Cheques/ Bank Draft

- Cheques and bank drafts must be drawn at a bank located in Malaysia in Ringgit Malaysia (RM), crossed and made payable to "Phillip Capital Management Sdn Bhd Client Account One" and attached to the application. Post-dated cheques will not be accepted.
- Cheque should be payable to "Phillip Capital Management Sdn Bhd Client Account One" Please submit the cheque together with all documents required to the Manager.
- For Multi-Currency in Off-Shore
  - o Cheque to be made payable to "Phillip Securities Pte Ltd".
  - o Please indicate your account name for depositing at the back of the cheque.
  - o Payments can be deposited directly into our bank account at any of the Maybank Berhad branches. Please fax or post a copy of the Deposit Slip to the Manager.
